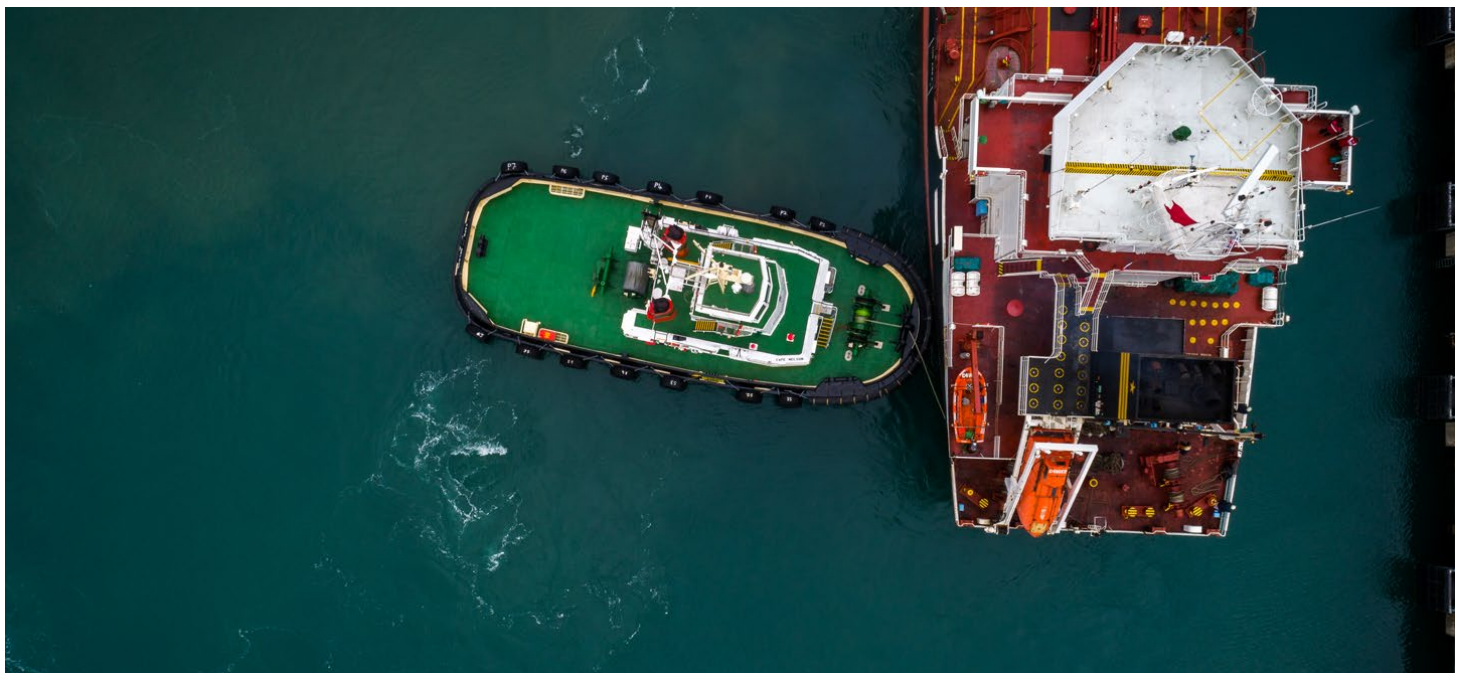

## EXPLANATORY NOTES

### **(A) SERVICES SLOT BOOKING FEE**

This charge applies to the booking of nominated grain loading services slot capacity. POPL will assess booking slot applications in accordance with the Port Protocols published on its website.

This is a non-refundable charge.

Any additional volume loaded above the nominated tonnage will be charged as part of the end of vessel reconciliation. Invoices are due for payment within 7 days of the booking. Any booking invoices not paid by the due date will result in the slot being cancelled.

This charge is a component of the Operating Services Fee.

### **(B) Operating Services Fee**

These charges cover the services and infrastructure provided by POPL for the Receipt of Grain through its Mobile Road hopper system and the Outturn of Grain into a Vessel on a 24 hours per day basis and have been calculated taking into account the pre-paid Booking Slot Fee detailed above in (A).

The Services covered above are separately charged as follows:

- (1) Use of the shiploading infrastructure and Link Road Grain Receipt.
- (2) Labour provided to unload trucks at the mobile road hopper and shiploading operation.

### **(C) Storage Space Fee**

This charge applies to the hire of POPL's storage facilities and is charged on a daily basis.

The fees will be reconciled at the completion of the provision of the services.

### **(D) Customer Transport Services Fee**

This charge applies to POPL's service of transporting Grain by truck from the Storage Space to POPL's Mobile Truck Unloader, for loading onto a Vessel.

The charge is applied on a per hour basis and separate fees are charged for trucks hauling Grain and trucks that are not working but on standby.

The charges are finalised and payment due at the completion of the services for the Vessel.

### **(E) Front-End Loader Services Fee**

These charges cover POPL's provision of a suitable front-end loader (Front-end Loader) and operator to assist with stockpiling Grain at the Storage Space, and also for the loading of Grain into trucks for the delivery of Grain to the Mobile Truck Unloader.

The fee is applied on a per hour shift basis for the loading of Grain into trucks for delivery to the Mobile Truck Loader and then onto the Vessel.

The fee is applied on a per hour basis where the Front-end Loader is being used for stockpiling Grain.

The charges are finalised and payment due at the completion of services.

### **(F) Additional Services Fee**

This charge covers all additional services not detailed above and of a type not covered as services contemplated in this Agreement.

Services could include the provision of Tally or Weighbridge Clerks, or other labour as required and will be charged on a per hour basis.

Additional labour may be required for infrastructure cleaning following the conclusion of shiploading services which is in addition to the shiploading labour provided.

Payment will be due on the completion of the services.

Prices for additional services are available on request.

**(G) Hatch/Hold Trimming Fee**

This charge covers the provision of services for the trimming of Grain in a Customer's Vessel undertaken by external providers contracted by POPL.

The fees are applied on a per shift basis with Payment due on the completion of the services.
