

1. Introduction

The Port of Portland recognises its impact on the environment and the need to provide environment initiatives to provide long term sustainable value creation and risk management. This Environment Strategy outlines our commitment to minimise any negative impact on the environment arising from our business activities.

2. Objectives

Our primary objectives in implementing this strategy, encompassing marine operations, infrastructure and administration are:

- **Emissions Reduction:** the efficient use of energy, sustainable practices, and responsible resource management across the company operations
- **Sustainability Integration:** To integrate sustainability principles into our business and decision-making processes
- **Employee Engagement:** To engage and educate our employees on the importance of understanding the environment we operate within and empower them to contribute to our environment goals
- **Transparency and Reporting:** To maintain transparency in our environment efforts and regularly report progress to stakeholders

3. Key Initiatives

To achieve our environment initiatives within the Port of Portland operations, we will undertake the following key initiatives:

A. Energy Efficiency and Renewable Energy

- Identify opportunities to improve energy efficiency across our facilities, including lighting, equipment, and logistics
- Invest in renewable energy sources for port infrastructure where feasible
- Regularly assess and upgrade energy-efficient technologies and equipment used within our operation

B. Sustainable Transportation (Including Shipping)

- Promote the use of cleaner transportation modes within the operations, including low-emission vehicles, plant, equipment, and efficient product handling practices
- Collaborate with customers to encourage the use of environment friendly vessels and sustainable shipping practices

C. Waste Reduction and Recycling

- Minimise the use of paper and other resources including by disseminating documentation electronically, discouraging printing and by printing double-sided where printing required

- Prioritise suppliers for the business who demonstrate strong environment commitments and sustainable practices
- Consider environment impacts when making procurement decisions related to port equipment and materials

E. Employee Engagement and Education

- Conduct regular environment awareness and education programs for employees
- Recognise and reward employees for their contributions to environment initiatives via the Betterways program

F. Reporting and Communication

- Regularly measure and report our impact on the environment associated with operations using recognised standards
- Communicate progress of our environment initiatives to employees, customers, investors, and the public through appropriate channels

4. Measurement and Monitoring

We will establish key performance indicators (KPIs) and regularly monitor our progress towards achieving our environment targets for company operations. We will use data-driven insights to adjust our strategies and initiatives as necessary to ensure continuous improvement.

5. Compliance and Regulatory Commitment

Port of Portland is committed to complying with all relevant environment laws and regulations pertaining to the environment we operate within. We will work proactively to meet regulatory requirements where feasible.

6. Conclusion

By implementing this Environment Strategy, Port of Portland aims to not only reduce its impact to the environment but also inspire positive change within our industry and communities, Port tenants, Port users and stakeholders. We believe that our commitment to sustainability is essential for a more sustainable and prosperous future.
