EXPLANATORY NOTES

(A) Services Slot Booking Fee

This charge applies to the booking of nominated grain loading services slot capacity. POPL will assess booking slot applications in accordance with the Port Protocols published on its website.

This is a non-refundable charge.

Any additional volume loaded above the nominated tonnage will be charged as part of the end of vessel reconciliation. Invoices are due for payment within 14 days or the booking. Any booking invoices not paid by the due date will result in the slot being cancelled.

This charge is a component of the Vessel Loading Fee.

(B) Vessel Loading Fee

Charged per tonne for POPL to provide labour and infrastructure for the Receival of Grain through the Mobile Road hopper system and the Outturn of Grain into a Vessel. Charge is calculated taking into account the prepaid Slot Booking Fee and to be reconciled following the provision of the vessel loading services.

(C) Accumulation, Storage and Outloading Service Fees

This storage throughput fee is a service charge for POPL to provides to labour and a front-end loader to receive, stockpile and outload delivered grain at the POPL storage facilities.

A storage fee is applied on a daily basis for each day grain is stored in POPL storage facilities.

POPL Transit Sheds are subject to availability.

(D) Additional Charges

Additional labour to be charged for a minimum 8 - hour during shiploading operations.

An additional flow path cleaning fee applies if an additional mid vessel loading clean is required due to infestation or a commodity switch.
